# Minutes of Special Meeting on December 7, 2010

The meeting of the Board of Fire Commissioners was called to order by President MacPherson at 6:00PM.

President MacPherson advised the Board that all requirements of the Open Public Meeting Laws have been met and this meeting was properly re-advertised as a special meeting to discuss and introduce the 2011 budget.

#### 2011 Budget Introduction

The Board of Fire Commissioners introduced the 2011 budget that total \$1,065,550.00 of which \$1,030,443 will be raised through taxation.

The district budget is within the 2% cap and the budget worksheet package will be submitted to the Department of Community Affairs, Local Government Services Office by Board Accountant Mike Bart.

On a motion by Commissioner Corson, Second Hawkins the Board of Fire Commissioners authorized Resolution 26-10 which Introduced the 2011 Budget to be forwarded to the Department of Community Affairs. Vote: Yes, full Board.

#### Other Business Discussed

<u>Special Capital Vote – Securing Voter Approval for Rescue Truck Purchase</u>
The Board discussed the results of the special election which resulted in voter approval to expend no more than \$850,000 to purchase a new rescue truck and equipment for said truck; voter approval was (22) in favor and (1) against.

The Board authorized an application to the Local Finance Board to pursue financing for the rescue truck under a lease purchase agreement. On a motion by Commissioner Hawkins, Second Corson the Board authorized Resolution 27-10. Vote: Yes, full Board.

FISCAL YEAR: From January 1, 2011 to December 31, 2011

WHEREAS, the Annual Budget for the BOROUGH OF TINTON FALLS Fire District No. 1 for the fiscal year beginning January 1, 2011 and ending December 31, 2011 has been presented before the Board of Commissioners of the Fire District No.1at its open public meeting of DECEMBER  $7^{\text{TH}}$  2010; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and,

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$ 1,065,550, which includes amount to be raised by taxation of \$1,030,443, and Total Appropriations of \$1,065,550; and

WHEREAS, the amount to be raised by taxation to support the district budget, shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 1 has taken into account the assessed valuation of taxable property in the Fire District No.1,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District No. 1, at an open public meeting held on DECEMBER 7<sup>TH</sup> 2010 that the Annual Budget, including appended Supplemental Schedules, of the BOROUGH OF TINTON FALLS Fire District No. 1 for the fiscal year beginning January 1, 2011 and ending December 31, 2011 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No. 1\_'s outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the BOROUGH OF TINTON FALLS Fire District No. 1 will consider the Annual Budget for adoption on JANUARY 18<sup>TH</sup> 2010.
