Attorney Braslow handed out copies of CHAPTER 206, An Act concerning fire district elections, amending various parts of the statutory law, and supplementing Title 40A of the New Jersey Statutes. Key Points: **BUDGET:** 1) Nothing changes. 2) All time frames exist. 3) Budget still 60 days prior to February election. 4) Budget Hearing and Adoption no more than 25 days prior to election date. 5) If Budget does NOT exceed CAP, it does not get voted on. 6) After DCA signs off on our budget, that is it. **TEMP. BUDGET:** Capital Appropriations Meeting from 6PM to 9PM can be part of our Regular Monthly Meeting. **ELECTION:** 1) All costs for Regular Election borne by the county. 2) Special Elections would be our costs. 3) Vacancies- no real provisions for holding new elections, sample ballots to be sent out. Need to file with the County Clerk before the last Monday in July. 4) Nominating petitions- 10 persons or 2% of population that voted in
